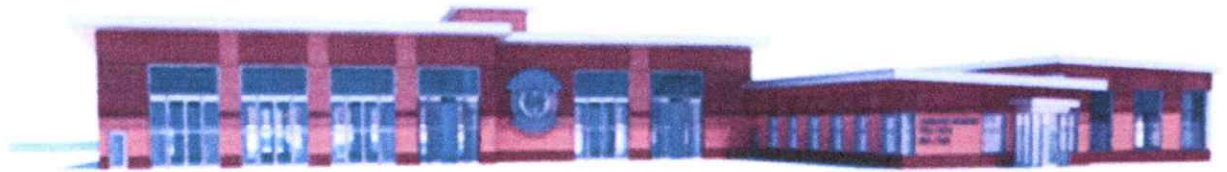

## FROM THE DESK OF FIRE CHIEF JEFF WENDT

On behalf of the members of the Crescent Springs-Villa Hills Fire Department (CSVFD), I would like to present our annual report for 2023. This report illustrates our commitment to the residents, visitors and businesses within our community. It also reflects our dedication to each other as a progressive fire service organization.

In 2022 the communities we protect are still burdened with COVID-19, increased cases of RSV and the common FLU. This continues to be a dangerous combination for our elderly population.

2023 saw a higher than average loss due to fire for a community our size. Total losses in the Cities of Crescent Springs, Villa Hills, and Unincorporated Kenton County are \$819,750.00, an increase of \$265,600.00 from 2022.

We are excited to be moving into our new building in 2024

## 2023 YEAR IN REVIEW

In 2023 the Crescent Springs-Villa Hills Fire Department saw an increase in our call volume. We responded to 1,546 emergency dispatches, an increase of 20 calls.

EMS or Ambulance calls totaled 1251 an increase of 80

Fire calls totaled 568, a decrease of 20 emergencies above 2023.

The CSVFD protects nearly 12,000 residents and 2.3 billion dollars in property.

In 2023 there were **ZERO** civilian fire deaths and **two** civilian fire injuries.

In 2023 there **ZERO** firefighter deaths and **Zero** firefighter injuries.

We continue to struggle with attracting veteran firefighters/Paramedics and have lost several due to retirements and to higher paying departments.



## **CRESCENT SPRINGS-VILLA HILLS INSURANCE SERVICES OFFICE (ISO) CLASS**

### **RATING: 2**

In 2019, the Crescent Springs-Villa Hills Fire Department secured a favorable ISO Public Protection Classification (PPC) rating of 2. Among the top rating for fire departments in the State of Kentucky and Nationally. Less than 5% of fire departments have received a class 1 or 2. This rating measures a community's capacity for fire prevention, and fire suppression, which influences the business community's insurance rates.

The ISO conducts a periodic review of the community's ability to respond and mitigate fire incidents. This review analyzes 911 call processing, pre-emergency planning, fire training/response and the distribution of fire resources, reliability of the water distribution grid is also measured.

In each community throughout the United States, ISO analyzes the relevant data using a Fire Suppression Rating Schedule. They then assign a Public Classification from 1 (best) to 10 (worst). Class 1 generally represents superior fire protection.

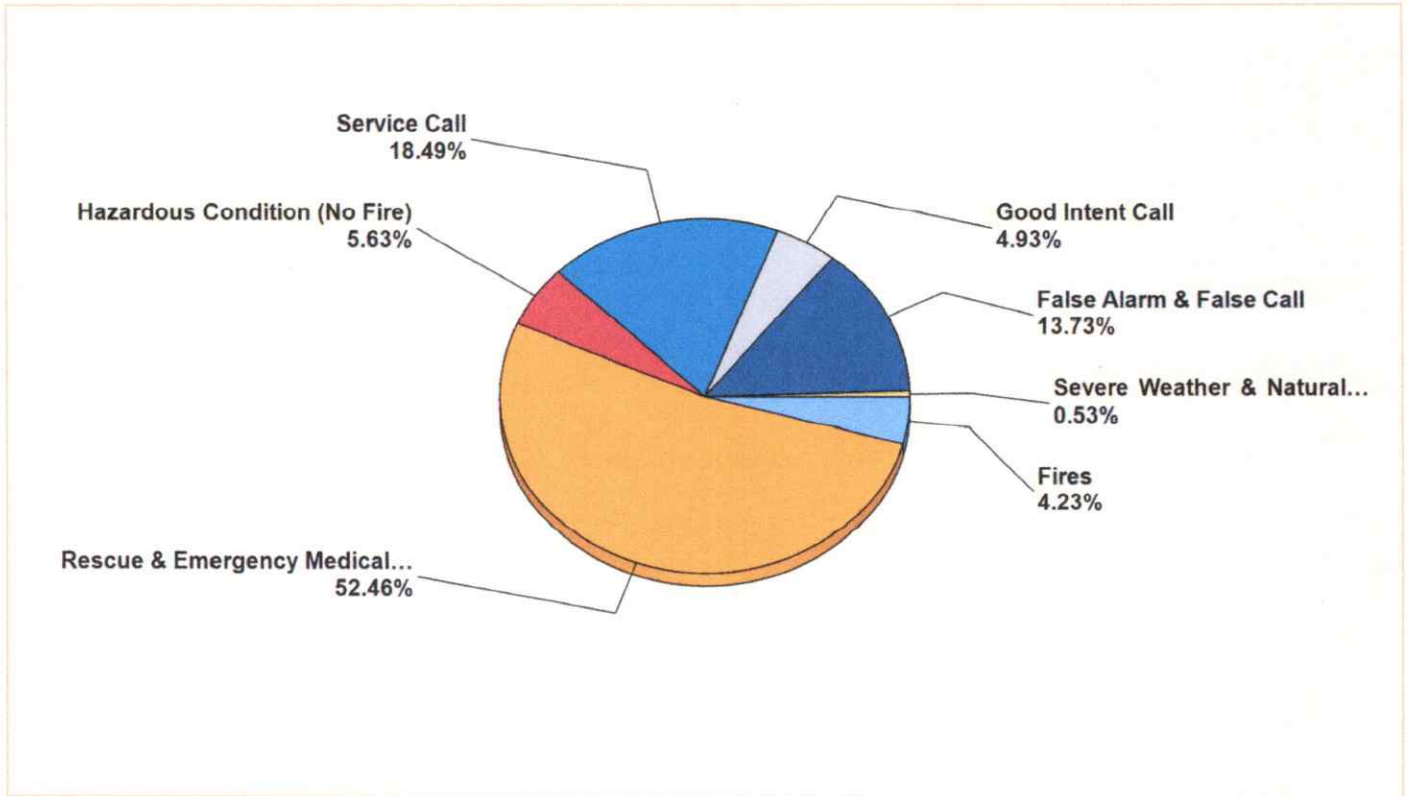

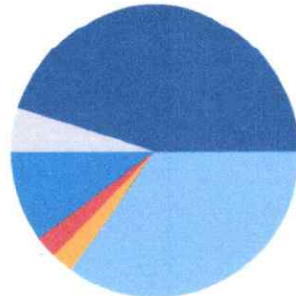

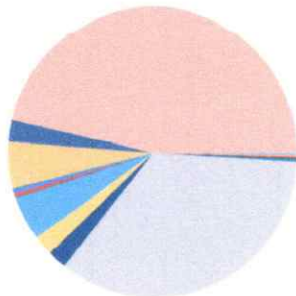
